The Cambridge Community Development Department (CDD) is accepting applications for 15 rental units affordable to middle-income households. These units are located in a newly constructed mixed-income building in East Cambridge/Kendall Square. Units are available to income and asset eligible households. Preference will be given to Cambridge residents and to families with children. There will be a one-time lottery to establish the order of applications.

Application deadline for participation in the lottery is 4:00 PM, Thursday, October 8, 2015.

Eligibility Requirements: Applicants must meet income guidelines stated below, have appropriate household size for available unit, and have assets no greater than \$100,000.
