## SUPPLEMENTAL INFORMATION: PJ Systems dba HiQ Computers

Description/Scope of Services: Mobile Device Management System

Amount of Contract: \$68,000

**Purpose:** The VMWare Airwatch mobile device management (MDM) solution will be employed by CPS to provide a mechanism to install a secure CPS "container" with CPS applications and data on personal devices.

The initial role out of the MDM solution will be coordinated with the district's transition away from FirstClass email to Gmail within the CPS GSuite for Education Domain. Unlike FirstClass email, Gmail does not provide a secure client for accessing school email on personal devices. This can only be accomplished with the addition of a third party MDM solution.

After an extensive investigation, testing period and formal bid process the VMWare Airwatch solution has proven to be the only MDM product that can meet all our needs. This MDM will allow CPS to manage a container, on staff personal devices that may contain CPS data. The MDM and CPS applications are installed at the staff member's discretion, yet ensures that any sensitive CPS data on personal devices remains under the control of CPS. CPS will have no access to any other portion of the staff member's personal phone.

Once in place the Airwatch VMware MDM solution will allow CPS to remain compliant with student data privacy requirements, ensure the protection of all CPS data on personal devices while enabling the innovation and mobility that our staff have come to expect. After the migration to Gmail, other core CPS applications may also be delivered to personal devices via the same MDM.
