### 1. Early Literacy Intervention (SC15632)

Description: These funds support ongoing professional development in Reading Recovery for Early Literacy Interventionist teachers who provide individual tutorial assistance to at-risk first grade students. The .38 FTE Teacher Leader, in addition to part-time teaching duties, supervises, trains, and conducts professional development for reading recovery teachers both in district and out of district.

CPS Target Population: All first grade students in all schools.

Outcomes & Measures of Effectiveness: The short term, tier 3 intervention of Reading Recovery will result in an increased number of students attaining grade level reading proficiency and fewer referrals for special education services.

Description: This is the first year of a three year 21<sup>st</sup> Century Community Learning Center grant. The Putnam Avenue Upper School (PAUS) /East End House (EEH) Out-of-School-time (OST) Partnership Program will engage and address high needs PAUS students' learning and developmental needs as well as contribute to meeting elements of the CPS Improvement Goals. A .66 FTE Data and Grant Projects Specialist will provide administrative support to fulfill all grant requirements and deadlines, including attending periodic statewide and regional meetings, administering data collection tools including surveys and other site-based assessments, and preparing grant reports.

CPS Target Population: Students in grades 6-8 at the Putnam Ave Upper School.
