Walker Partnerships mission is to assist school districts, educational collaboratives, Charter Schools, approved special needs schools and community-based human service agencies in building their capacity to serve students with special needs.

*Proposal:* Provide a Facilitated Discussion and ongoing Program Consultation to strengthen the therapeutic interventions, social-skills instruction/development and the rigorous academic instruction of the Structured Academic Program, grades K-12 within the Cambridge Public Schools.

#### Scope of Service:

Walker Partnerships has been requested to submit a proposal to conduct a day long Facilitated Discussion and ongoing Program Consultation to the staff of the Structured Academic Program.

#### Part I. Facilitated Discussion

The Facilitated Discussion process is designed to assist the district in the development of operational guidelines for programming that serves student with emotional disabilities. Walker Partnerships' staff will work with program and school based staff through a discussion process that defines mission, values, student outcomes, roles and responsibilities, clinical and behavioral intervention strategies, development of behavioral and treatment plans, entrance/exit criteria, student progress, data collection and program description. This process enables the district staff to define the attributes and characteristics of the program while having expert guidance facilitate the process. Supportive conversation leads to an outcome that all participants can agree with. The Facilitated Discussion process is a day-long activity that requires the participation of building administrators, program administrators and staff, and school-based staff who interface with the program classes.

#### Cost of Service:

The charge for this service is \$4,500.00. This is all inclusive for three Walker Partnerships' staff for a full day on-site, preparation time and travel time and expense. Billing will occur in one installment following the completion of this service

#### Conducting the Service:

#### Part II: Program Consultation:

Walker Partnerships will provide six (6) hours a week of Program Consultation to the three levels of programming to the Structured Academic Program at the Baldwin School (k-5), Rindge Avenue Upper School (6-8) and the Cambridge Rindge and Latin School (9-12). This consultation will focus on the operational and functionality of each classroom and the program as a whole. A major goal of the consultation will be to strengthen the daily instructional, therapeutic and behavioral practices and procedures as it relates to student progress. Emphasis will be placed on evidence based practice for instruction, therapeutic and behavioral support sand interventions.

#### Cost of Service:

The charge for this service is \$25,740.00. This is all inclusive for 6 hours of on-site time weekly for 26 weeks beginning December 1, 2015. Billing will occur in six equal installments of \$4,290.00 on a monthly basis beginning in January 2016.

#### Conducting this Service:

Mia Klinger-Powell, Ed. M., Education Coordinator for Walker Partnerships. Michael Carter, LICSW, Clinical Coordinator for Walker Partnerships. These service providers will coordinate their schedule based on program issues and needs during the service period. Assistance by each individual will be determined by the focus of the consultation on a weekly basis.

## Part III. Wrap-Around Meetings and Staff Training:

Walker Partnerships will proved Four (4) hours a month of wrap-around and staff training tome to the staff of the program. The focus of the meetings and the training will be determined in consultation with the Administration of Student Services and the



identified needs of the students, staff and the program. The use of these four hours will be determined in advance, may be broken out in 90 minute, 120 minute or entire four hours blocks of time.

# Cost of Service:

The charge for this service is \$4,620.00. This is all inclusive for twenty-eight (28) hours on-site. Billing will occur in six equal installments on a monthly basis of \$770.00 beginning in January 2016

## Providing this Service:

Walker Partnerships will assign this activity primarily to Misa Klinger-Powell. However she will be able to draw on other Walker Partnerships staff as well as other Walker resources to assist in this activity.

#### Stipulation:
