# SUPPLEMENTAL INFORMATION: Marilyn Friend

Purpose: Professional Development

Amount of Contract: \$30,000

### **Description/Scope of Services:**

Since the fall of 2015, the Office of Student Services has partnered with various schools to improve the inclusive practices that are occurring in schools for students with disabilities. The driver of this work was a result of recommendations of an evaluation of co-teaching that was conducted by Dr. Marilyn Friend.

During this school year, we will continue to improve and refine the special education services and inclusive practices occurring at the Vassal Lane Upper School by facilitating co-planning sessions and offering feedback. In addition, we will conduct school and classroom visits of the high school, four upper schools and Haggerty School to gather data to measure our growth over the past two years.

- 1. Five on-site visits during the 2018-2019 school year.
- 2. Professional development at a school site for small groups of teachers. This PD is usually during the school day.
- 3. Professional development for larger groups of teachers, usually from several schools. This type of PD often is after school, occasionally during the school day. One example from last year was a day spent with special education teachers on the topic of specially designed instruction.
- 4. Classroom visits and coaching related to co-teaching, specially designed instruction, and related practices.
- 5. Consultation with principals and school leaders on co-teaching, specially designed instruction, and other special education topics.
- 6. Consultation with OSS central office staff on the work to expand and refine inclusive practices.
- 7. Provide written feedback as an update to the recommendations from the co-teaching report that was conducted 2017-2018 school year.
